

Gojko Ostojić (1 person) - police operations “Storage 1 & 2” and “Transporter”

Indictment filed on 1 January 2025

Introduction

A prosecutor of the Prosecutor’s Office of Bosnia and Herzegovina filed an indictment against Gojko Ostojić, according to which he is charged that he, as a member of an organised crime group, together with the organisers and members of the group previously accused in the Bojan Cvijetić et al. case, with the aim of obtaining illicit property benefits, carried out the international smuggling of the narcotic drug “cocaine”. The defendant was extradited from the Czech Republic based on an international warrant issued by the judicial institutions of Bosnia and Herzegovina.

Name(s) of the defendant(s)

1. *Gojko Ostojić, born in 1977 u Nikšić, citizen of Bosnia and Herzegovina*

Indictment

The defendant, as a member of an organised crime group, using specially adjusted mobile phones with installed Sky Ecc and Anom applications, which were intended for establishing protected, encrypted communications, is charged with the international trafficking, sale and transfer of the narcotic drug “cocaine”, which was purchased in EU countries, the Czech Republic, the Kingdom of Belgium and the Kingdom of the Netherlands, and which had been previously smuggled from South America.

The indictment states that the organiser and the defendant Gojko Ostojić agreed to buy and sell a certain amount of narcotic drugs in the territory of the Kingdom of the Netherlands with a person known to them, part of which, according to an earlier agreement, was handed over to a person known to them in the territory of the Republic of the Czech Republic, while the other part of the narcotic drugs was transported and further sold in Bosnia and Herzegovina. The defendant Ostojić arranged the transport of the narcotic drugs with the organiser and other members of the group.

Alleged criminal offences

Organised crime (Article 250 (2) of the Criminal Code of Bosnia and Herzegovina), in conjunction with the criminal offence of Illicit trafficking in narcotic drugs (Article 195 (1) of the Criminal Code of Bosnia and Herzegovina).

Investigation

The Prosecution plans to substantiate the allegations in the indictment by calling witnesses and expert witnesses, and by submitting material evidence, including documents obtained through mutual legal assistance from institutions in France, the USA and other countries.

Court proceedings

The indictment was confirmed on 7 January 2025.

Guilty plea: On 18 February 2025, the defendant pleaded not guilty.

Commencement of the main trial: 18 February 2025.
