Biography

IVAN MATEŠIĆ – PROSECUTOR OF THE PROSECUTOR'S OFFICE OF BOSNIA AND HERZEGOVINA

Ivan Matešić was born in Prozor, Prozor-Rama municipality, Bosnia and Herzegovina, on 7 February 1975.

He graduated from Mostar University Faculty of Law in January 2000.

He was employed in November of the same year, first as an intern and later as a Judge at Prozor Municipal Misdemeanor Court and held this position until June 2007.

He passed the bar exam before the Federation Ministry of Justice panel in 2004.

From 2007, he served as an adviser of Feliks Vidović, Federation Minister of Justice, and was appointed Assistant to the Federation Minister of Justice for administration on 1 December 2008.

He was appointed Prosecutor of the Prosecutor's Office of Bosnia and Herzegovina by a decision of the High Judicial and Prosecutorial Council of Bosnia and Herzegovina in November 2013 and took office on 1 December 2013.

He is a member of the Bar exam Commission at the level of the Federation of Bosnia and Herzegovina. He has continuously served in the commission since the end of 2009, first on the Constitutional system and organization of the judiciary and currently on Administrative and Labor Law.

He is a trainer at the preparatory seminars for the bar exam that are held throughout the territory of the Federation of Bosnia and Herzegovina.

In the period from 2008-2013 he was the president or member of various professional authorities, appointed by the Council of Ministers of BiH, the Government of the Federation of BiH and competent line ministers, as well as international organizations including inter alia:

- Member of the Team for monitoring and coordinating the implementation of the Federation of Bosnia and Herzegovina Government's general anti-corruption plan - appointed by the Decision of the Government of the Federation BiH
- President and member of the Commission for professional exam for employees in the administrative bodies in FBiH - appointed by the decision of the Federal Minister of Justice

- Member of the commission for pardoning convicted persons in the Federation of Bosnia and Herzegovina – appointed by decision of the Federal Minister of Justice
- Member of the commission for selection of court interpreters from the Federation of Bosnia and Herzegovina – appointed by decision of the Federal Minister of Justice
- Member of the commission for public procurement of the Federal Ministry of Justice – appointed by decision of the Federal Minister of Justice
- Member of the commission for supervision of the work of notaries in the Federation of Bosnia and Herzegovina – appointed by decision of the Federal Minister of Justice
- Member of the management board of the project to strengthen the capacity of local self-governance units in the Federation of BiH - appointed by UNDP
- Expert of the Association of Municipalities and Cities of the Federation of Bosnia and Herzegovina during implementation of the program of the Swiss Embassy related to strengthening the capacities of local self-governance units

He was also the president or member of other professional bodies drafting laws and bylaws at the level of BiH and the Federation of BiH.
