

INFORMATION - SKY AND ANOM CASES WITH CONFIRMED INDICTMENTS

Bibić Sako at all (5 persons) - action "Diablo";

Indictment filed February 15, 2023.

Introduction

Indictment filed in the case with evidence from Sky and Anom applications in the case of Sako Bibić and others. The accused were charged with trafficking of marijuana.

Name(s) of accused person(s)

1. Sako Bibić, born in 1973 in Skopje, citizen of BiH and North Macedonia
2. Eldar Hujčić, born in 1979 in Sarajevo, citizen of BiH
3. Admir Halimanović, born in 1985 in Sarajevo, citizen of BiH
4. Alem Zukić, born in 1991 in Sarajevo, citizen of BiH
5. Đoko Komar, born in 1993 in Nikšić, citizen of BiH and Montenegro

Indictment

The indictment alleges that the accused, using secure applications, coordinated criminal activities involving smuggling, transportation, concealment, and distribution of substantial quantities of marijuana to EU countries, particularly Croatia, Germany, the Netherlands, and Poland. This illicit drug trade resulted in significant financial gains, which were subsequently utilised to acquire real estate and luxury vehicles, constituting money laundering. The indictment also seeks the confiscation of unlawfully acquired property benefits exceeding 300,000 BAM.

Accused criminal offences

Organised Crime (Article 250 of the Criminal Code of BiH), Unauthorised Trafficking in Narcotics (Article 195 of the Criminal Code of BiH), Money Laundering (Article 209 of the Criminal Code of BiH), Unauthorised Possession of Weapons or Explosive Substances (Article 371, paragraph 1 of the Criminal Code of the FBiH), all in conjunction with Article 53 of the Criminal Code of BiH.

Investigation

The prosecution will prove the allegations of the indictment by calling more than 20 witnesses and expert experts, as well as by attaching dozens of evidentiary materials.

Court proceedings

Indictment confirmed: February 23, 2023.

Guilty plea: At the arraignment held on 23 March 2023 the accused Sako Bibić, Admir Halimanović, Eldar Hujčić, Alem Zukić and Đoko Komar all entered a not guilty plea concerning the criminal offences they have been charged.

Main trial commenced: April 19, 2023.

Case status: Prosecution presents evidence.

Verdict

The accused Zukić Alem (1991) voluntarily admitted guilt on 23 June 2023. Zukić received a 1-year prison sentence, a secondary fine of 4,000 BAM, and the confiscation of unlawfully acquired property amounting to 2,000 EUR.
